The Board meet with Dave Mazaroff, M & N Assessing. The Board discussed the taxation of Solar Panels. Jim Coffey made a motion to begin assessing properties that have installed Solar Panels according to the N. H. law. Frank seconded the motion and it passed unanimously. Dave will add it to our assessing system beginning April 1, 2016. The Board will schedule a meeting with the Board of Selectmen to discuss exemptions which will include solar panels.

Jim stated he would like to see box trailers taxed and Dave stated they could be taxed at a flat rate.

Dave discussed the land use change tax for the Old Beaver Road properties. He waited to have adequate data before assessing. Dave stated if San-Ken wants to appeal the assessment, they can certainly do that.

The Board discussed the Central School property that is now being worked on. The owner would like to see a small restaurant in the building along with office space on the second floor. Dave has the property listed as commercial office space and will be taxed this year.
