PETITION PURSUANT TO RSA 231:163 FOR CHANGES IN POLE AND CONDUIT LICENSES ISSUED UNDER THE AUTHORITY OF THE BOARD OF SELECTMEN OF THE TOWN OF NEW IPSWICH

TO THE BOARD OF SELECTMEN, TOWN OF NEW IPSWICH, NEW HAMPSHIRE:

The undersigned, in her capacity as Town Administrator of the Town of New Ipswich, New Hampshire, and a resident of New Ipswich, New Hampshire, being a person whose rights and/or interests in such capacity are affected by all existing and outstanding so-called pole or conduit Licenses, issued pursuant to RSA 231:161, under the authority of the Board of Selectmen of the Town of New Ipswich, hereby petitions the Board of Selectmen of the Town of New Ipswich, acting pursuant to authority conferred upon the said Board of Selectmen of the Town of New Ipswich by virtue of the provisions of RSA 231:163, to adopt the following changes to all currently issued and outstanding pole or conduit Licenses heretofore issued by or under the authority of the Board of Selectmen of the Town of New Ipswich or by their predecessors in office, including, but not limited to, all Licenses currently in effect by Orders of the Board of Selectmen or pursuant to all Petitions filed pursuant to RSA 231:161 with the Town of New Ipswich, by adding the following language to all such pole and conduit licenses, based on the law of New Hampshire, which recognizes that the public good is satisfied if such licensees are assessed real and personal property tax for their use of the public right of ways for their poles or conduits, to wit:

In accordance with the requirements of RSA 72:23, I (b), the licensed entities and any other entity now or hereafter using or occupying municipal property pursuant to this License shall be responsible for the payment of, and shall pay, all properly assessed personal and real property taxes no later than the due date. Furthermore, in accordance with the requirements of RSA 72:23, I (b), the licensed entities and any other entity using and/or occupying property of the municipality pursuant to this License shall be obligated to pay real and personal property taxes on structures or improvements added by the licensed entities or any other entity using or occupying the property of the municipality pursuant to this License. Failure to pay duly assessed personal and real property taxes when due shall be cause to provide a written notice to the licensed entities to show cause by a date certain specified in the notice as to why this License should not be terminated for nonpayment of the sums due.

In accordance with the requirements of RSA 72:23, I(b), this License is granted to

the licensee(s) subject to that condition that the licensee(s) and any other entity now or hereafter using or occupying municipal property pursuant to this License shall be responsible for notifying, within 90 days of the date of this amendment, each attacher to a licensee's pole(s) and/or licensee's conduits by serving a copy of the herewith Petition on each such attacher and submitting to the clerk of the Town of New Ipswich, a complete list of attachers to each pole or conduit in the Town, listing the pole or conduit locations of each attacher. Further, this Licensee's granted subject to the condition that the Licensee(s) and any other person now or hereafter using or occupying municipal property pursuant to this License shall update annually the information provided to the Town with the Town Clerk on or before May 1st of that year, including the location of any additional attachers including the location of the pole(s) or conduit(s) to which the attachers' facilities are attached, any attachers that have removed their attachments and/or any attachers that have added new attachments.

This license is granted upon the condition that the petitioner(s), licensee(s), heirs, and assigns shall, to the fullest extent permitted by law in perpetuity, protect, indemnify, save, defend and hold harmless the Town of New Ipswich, including its officials, agents, and employees, from and against any and all liabilities, obligations, claims, damages, penalties, causes of action, costs, interest and expenses, including but not limited to reasonable attorney fees, by reason of any accident, bodily injury, personal injury, property damage, or death of any person arising from the use of the municipal right-of-way for utility purposes.

This license is further granted upon the condition that the petitioner(s), licensee(s), heirs, and assigns shall be required to relocate such pole(s), structures, conduits, cables, and/or wires, together with protecting fixtures as set forth in said Petition, upon written request of the Town of New Ipswich, within a reasonable time frame at no charge to the Town.

Dear Mr. Talbot:

The New Hampshire Department of Transportation (NHDOT) is pleased to inform New Ipswich that bridge aid funding is planned to be available for the rehabilitation or replacement of the above noted bridge.

As part of the upcoming Ten-Year Plan process, NHDOT will reduce the number of red listed bridges statewide with our available State and Federal bridge funds. Based on NHDOT bridge inspection data and this bridge's current poor condition, the above noted bridge is considered one of up to 65 candidates for funding. Our bridge aid programs are funded with 80% State or 80% Federal funds with the municipality responsible for the 20% local match. These programs are "reimbursement" type grants in which the municipality covers 100% of preapproved project costs initially and is subsequently reimbursed NHDOT's 80% share of eligible costs incurred.

Based on very preliminary data, NHDOT estimates the cost to rehabilitate or replace the above noted bridge is approximately \$1,101,600.00. The municipality's 20% share is estimated to be approximately \$220,320.00. The actual project cost and local share will depend on the design of the bridge, inflation, and other project related factors not possible to know at this time.

NHDOT is currently beginning the enrollment process for the bridge aid program for official acceptance in the next Ten-Year Plan cycle anticipated to be approved in the summer of 2024. Accepted Ten-Year Plan approved bridge projects will be programmed for construction in years 2027 thru 2032.

Although we can't guarantee that funding will be available to enroll your project, we would like to know if your municipality is interested in applying for funds? This will allow us to better develop our local bridge aid program for the upcoming Ten-Year Plan cycle. If New Ipswich is interested or not interested in beginning the enrollment process with NHDOT for the above noted bridge, please check the appropriate response below and return a copy to me via my email noted below by April 15, 2023.

Re: Notice #2023-02: Local bridge funding available for 65 poor condition red list bridges

The NHDOT bridge inspection section inspects all locally owned bridges on legislative Class IV and Class V highways at least every 2 years. As part of our inspection process, the NHDOT has a list (referred to as the "red list") of locally owned bridges having at least one major structural element (deck, superstructure, substructure, or culvert) classified as being in poor condition with a score of "4=Poor" or less according to the NBIS (National Bridge Inspection Standards) scale. As of 2022, there are 222 red-listed locally owned bridges in New Hampshire. 43 of these red list bridges are already enrolled with the NHDOT for rehabilitation of replacement, leaving 179 other locally owned red list bridges across the state in need or rehabilitation or replacement.

In an effort to reduce the number of red list bridges further, the NHDOT has reviewed and ranked locally owned red list bridges primarily in terms of NBIS condition. Based on \$90 million dollars of available funding, the NHDOT has identified the 65 highest ranking red list bridges to fund as part of the next tenyear plan process.

The 65 bridges as shown on the attached map are planned to be programmed for construction over six (6) years beginning in 2027 and going thru to 2032, with planning and engineering beginning as early as state fiscal year 2025 (begins July 1, 2024).

The NHDOT is currently contacting directly the 65 communities identified on the attached map to ask if they would like to enroll in a bridge aid program to rehabilitate or replace their red listed bridge.


