### 5:15 Fire Chief-Gary Somero:

Also in attendance: Ben Hatcher-Deputy Fire Chief

Gary submitted information he had done over the last 16 weeks regarding the possibility of a full time Fire Chief/Building Inspector/Code Enforcement Officer position and how it breaks down. He added they are working with Mitch to develop the budget for next year and would like to know the direction to go in.

Shawn added he thinks it should go on a warrant article to see if the Town would approve the position, Jason agreed. Gary said it could also go in the budget. Shawn added he thinks we would have the support of the Town.

Gary stated interviews would be done by an independent board so they ask the right questions and there could be no bias. Hopefully the applicants would also have Building Inspection experience. The positions overlap somewhat because the Fire Chief's responsibility is also to do Life/Safety Inspections for Certificates of Occupancy, Foster Care and Schools.

Jason asked about the interview process. Gary said they would have Fire Chiefs from surrounding towns conduct the interviews. Gary would then recommend candidates to the Selectmen.

Shawn asked if Gary feels the position warrants full time. Gary said it most definitely would. He added we are losing revenue due to expired permits and our Building Permit fees are lower than surrounding towns. There is a lot of administrative work to the position. We would have the ability to do additional inspections if it was a full time position.

Gary added there are grants available but writing grants are time consuming and having a full time position will allow time for that.

Gary said he has done 146 inspections in the past 16 weeks. Code Enforcement is also very busy. He added he prefers to have face to face connections with people to help them solve issues. There are a lot of new

doing balloon rides from 3:00-5:00pm. The bonfire will be from 6-8pm. The Fire Department will be manning the snack shack. They will also be taking pre-orders for ½ bbq chickens. There will be trucks (DPW, fire, excavators, dump trucks, concrete trucks, etc.). There is no admission fee. A lot of crafts will be free. Some rides will require tickets. Planning Board will be donating 200 mini pumpkins for painting. There will be face painting, balloon animals, Bruce Ruotsala will be bringing a sauna to the park. There is also a custom T-shirt person, some Farmer's Market people will also be there. Congregational Church has donated tables and chairs for the Town to use. Mike Ordway will be doing music and doing music instruction.

It was also mentioned about the Town raffling a basket of Town items (Transfer Station sticker, bags, etc.). Jason suggested a resident could purchase these items and raffle it.

- Jason said we should review all things that need a permit to see if we need to keep them (roofing permit?)
- There is a Heritage Commission meeting on Monday and we need to decide how to pay for the maintenance of the clock. It was decided it should come out of General Building Maintenance. Shawn suggested the Heritage Commission keep track of it as well. Debbie suggested we separate the clock maintenance as a separate line.

Ron Stanley asked about getting a key from the church for Bruce Aho to access the clock. Shawn said he was working with Mike Martel regarding the key. He also mentioned having 2 people enter the church for whoever is maintaining the clock and to give a 24 hour notice. We don't own the building so we should respect their property.

At 6:49, Shawn made a motion to adjourn. Jason seconded the motion and it passed unanimously.

In reference to full time Fire Chief/Building Inspector. Need to get a decision on the hiring of a full time Fire Chief/Building Inspector position, as we are working to establish the 2024 budget. We would need the proper time frame for advertising the position and interviews.

- 1. Approval for adopting the position
- 2. Setting a salary scale
- 3. Finalizing the job description
- 4. Advertising the position
- 5. Conducting interviews
- 6. Hiring a candidate

Consideration on the salary and budgeting of the new position identifying on a scale of economy with current positions budgeted.


