Discussions

Insurance

- New Ipswich offers health and dental insurance through School Care.
- The following health care options with 2022 monthly prices are available. Prices are fixed from July 1, 2022 to June 30, 2022.

Status of budget development efforts

- Overall the team felt significant progress was made, but draft budgets are not available at this time.
- Each member of the FAC will provide a summary of each Department Status to the FAC Chair (Dennis), and he'll consolidate the FAC input for presentation to the BOS.
- It is important to note that the Department Heads have been fully supportive in this effort.

Communication Expenses

• Two communication line items do not appear to have owners:

- The SWNH FIR MUTUAL AID will be moved from 01-4299 account to the Fire Department.
- Joe will research HILLSBORO COUNTY communications. Update:
 - Joe reached out with Chief Abel. HILLSBORO COUNTY provides dispatch services for New Ipswich, 24x7. This line item is required.
 - We'll move this line item into the PD budget to clean up the books
 - NOTE: This will not impact the PD budget negatively (i.e. it will not appear as an increase in year-over-year spending).

Other items:

- Mileage
 - Mileage reimbursement pricing is established by the IRS and is updated annually (July 1, 2022 to June 30, 2023). For this period, we should be using \$0.625 per mile.
 - Account line items reflecting travel should be reviewed (and updated if necessary) to further break down travel expenses (e.g. Flight, Meals, Hotel, Mileage, etc.). These should be consistent across all Departments.
- Account Names
 - Account names and descriptions can be confusing. For example:
 - Account Group: Moderator
 - Account Line: Moderator Election Day (truncated)
 - Actual Account Line in system: Moderator Election Day Meals
 - Suggested Account Line: Election Day Meals
 - Comment: We do not need the Account Group in the Account Lines.
 - \circ FAC and Debbie will work together to have Account Line Items cleaned up as necessary.
- Reimbursed Expenses
 - Some expenses incurred by Departments are reimbursed through their fees. Any program that P&R collects fees for should not be included in the line item P&R general fund budget. Fees collected go into a revolving fund.
 - These expenses are tracked individually by the Department Heads, but should not be included in the Department operating budget.
