Paul was gone. They told me they had searched the house, car and garage. I contacted HCSO to see if we could get NIFD to form a search team. NIFD was unavailable due to a woods fire. NHFG was notified and FG40 arrived at 1826. He advised me other NHFG officers were enroute, as well as NHSP k9 units. With owner's permission we searched the garage, the car and the house for Paul. He was not there. I made continuous perimeter checks of Boynton Hill Rd., Appleton Rd., Thayer Rd., Greenfarm, Rd., Kenneybeck, Rd., Stowell Rd., Hollyview Rd. and Temple Rd. , while advising anyone I saw to keep an eye out for the missing gentleman and report such if seen.
