1. Introduction

The Town of New Ipswich is seeking proposals from qualified contractors to remove 45 trees along Old Wilton Road, per instruction of DPW Director.

2. Scope of Work

The selected contractor will perform the following services:

- Cut 45 trees along both sides of Old Wilton Road marked with orange ribbon.
- Remove all branches and debris associated with the effected work area.
- Logs will be left for the landowners of Old Wilton Road.
- (If Applicable) Grind 7 stumps along the side of Old Wilton Road. (Separate quote on bid needed)
- Tree removal to be completed by 5-31-25

3. Contractor Qualifications

The contractor must meet the following qualifications:

- Have experience and knowledge with removing small and large trees near power lines.
- Contact Eversource regarding all trees that are within 10 feet from primary power lines.

4. Proposal Requirements

Proposals must include the following information:

- Company name, address, and contact information.
 - Description of experience and qualifications relevant to the scope of work.
 - Detailed pricing structure for the required services, including labor, materials, and any additional fees.
 - Proof of Liability Insurance (\$1,000,000.00 minimum).

 - References from previous clients.
 - Ability to meet the Town's timeline and service requirements.
