The meeting was called to order at 1:30 p.m.

Old Business:

The minutes of the July 16 meeting were read and approved.

New Business

Jeff presented his revised fund ledger sheet. He has added the fund purpose information and expenditures. It is an accurate and up to date financial snapshot of the fund including actions and their dates. He also presented a flow chart that details the steps and actions representing the process of properly administering a fund. Both were discussed and minor changes made.

The filing cabinet is overflowing and becoming unmanageable. An approach appears to determine the retention requirements of the document types and discard older ones. Another is to save as required, or for an established period, and scan the remaining. Once scanned, the paper documents can be discarded.

We need two additional file cabinet keys. Jeff and Bob have them but Debbie and Bert also need them.

Three requests for distribution were acted upon:

- NTE \$2,800 from Parks & Recreation CRF to repair lighting at Memorial Park, was given preapproval,
- \$480 from the 275th Anniversary trust for an American Sign Language lecture was approved, and
- \$74,250 from Fire Department CRF to purchase a Utility Truck, was held for our next meeting. We were unsure if a utility truck was a permissible use; investigation needed.
